## Terms and Conditions for Enrolment

### Statutory Obligation to pay school fees

1. I/We hereby apply to have the learner whose name appears on this form as a pupil at Bryanston Parallel Medium School and confirm that he/she conforms to the basic criteria for a pupil to be enrolled in a particular school or grade.
2. I/We hereby certify that I/We are the biological/adoptive parents and that I/We have legal custody and/or legal guardianship in respect of the above named learner.
3. I/We undertake to adhere to the terms and conditions stipulated herein.
4. I/We understand and confirm that the Principal or any person duly authorised will act *in loco parentis* in any matter and at any time during which I/We have entrusted our child/ren to the care of the school during formal school hours and / or formal school activities.
5. I/We take note and understand the following:
  - a. Compulsory annual school fees will be approved by most parents at a general meeting held every year.
  - b. School fees are due and payable annually, in advance and are due on the first day of school.
  - c. To reduce the financial burden on parents, ELEVEN EQUAL instalments commencing January and ending November of each academic year will be acceptable.
  - d. Terms of payments are as follows:

- e. If school fees are paid in full on or before 31 January, then a discount will be deducted from your annual school fees. The percentage discount will be revised annually at the AGM.
  - f. In the event that parents are in arrears with one instalment, then the full amount becomes due and payable immediately.
  - g. A non-refundable development fee for **new learners** is payable on acceptance.
  - h. Biological/adoptive parents are jointly and severally liable for the payment of the school fees irrespective of their marital status.
  - i. In the event of non-payment of school fees, the school will institute legal action against both parents irrespective of maintenance and court orders which may exist between the parties.
  - j. In terms of Section 39 of the South African Schools Act, parents are liable to pay compulsory school fees. As this amount is statutory, it does not fall within any debt counselling agreement.
  - k. In terms of Sections 40 and 41 of the South African Schools Act, the school may enforce payment of these compulsory fees.
  - l. The parties to this application undertake to pay all legal costs including attorney / client fees and collection costs incurred by the school in the event of the school having to take legal action for the recovery of fees.
  - m. I/We have been informed that if we are unable to pay school fees, we may apply for exemption of these fees. Exemption application forms must be collected from the finance office. Foreign Nationals will not be able to apply for exemption.
  - n. If Parent/s fail to meet their school fee obligations, the school may record the parent/s non-performance with a bureau.
6. I/We undertake to give 30-day notice in writing of any intention to remove my/our child/ren from the school and furthermore to return any books and/or equipment belonging to the school which my/our child/ren might have.
  7. I/We, herewith give the school consent to:
